The Government of India has received financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Mumbai Urban Transport Project – III (MUTP-III) and intends to apply part of the proceeds toward payments under the contract for “Design, Supply, Installation, Testing and Commissioning of Indoor equipment/gears for Signalling works in connection with Virar (VR)-Dahanu Road (DRD) quadrupling project in Mumbai Suburban”.
2. The Mumbai Railway Vikas Corporation Ltd. now invites online Tenders from eligible Tenderers for “Design, Supply, Installation, Testing and Commissioning of Indoor equipment/gears for Signalling works in connection with Virar (VR)-Dahanu Road (DRD) quadrupling project in Mumbai Suburban (MUTP-III)” Project under MUTP-III as detailed in the Table below. Tenderers are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 5.9 of the “Procurement Policy of January 2016” and paragraph 4.4 of “interim Operational Directive on Procurement Instructions for Receipts, June 2016” setting forth the Asian Infrastructure Investment Bank’s policy on conflict of interest.
3. Tendering will be conducted through International Open Competitive Tender (IOCT) using Invitation for Tenders (IFT) as specified in the Bank’s Procurement Instructions for Recipients” (PIR) and is open to all eligible Tenderers as defined in the PIR.
4. Interested eligible Tenderers may obtain further information from undersigned and inspect the Tender document during office hours 10.00 Hours to 18.00 Hours (IST) at the address given below.

5. The Tender document in English is available online on <https://eprocure.gov.in> from **15/02/2024 to 03/04/2024**. Tenderers will be required to register on the website. The Tenderers would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tenderer has to submit the tender only on the procurement website <https://eprocure.gov.in>.
6. For submission of the tenders, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (www.cca.gov.in). Aspiring tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://eprocure.gov.in>.
7. Tender comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted online on <https://eprocure.gov.in> on or before **15.00 Hrs of 03/04/2024 (IST)**. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic Tendering system would not allow any late submission of tender. The "TECHNICAL PART" of the Tenders will be publicly opened online **on the same day** in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at **15.30** hours (IST), and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the Tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tender will be opened on the next working day at the same time and venue.
8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of Mumbai Railway Vikas Corporation Limited, Payable at Mumbai. Tender security will be submitted in accordance with the clause ITT (TDS) 21.3 in section-2 of the tender document.
9. **The tenderers are required to submit following original documents on or before the tender submission deadline as mentioned below (refer clause 24.3 of ITT in section 2).**
 - (i) original tender security in approved form
 - (ii) original affidavit regarding correctness of information furnished with tender document, with the office **specified in the TDS 24.1**,
 - (iii) Power of Attorney (as per ITT 22.2 **of ITT in section 2**)

either by registered post/ speed post/ courier or by hand, failing which such tenders will be declared non-responsive, and will not be opened. The employer, MRVC is not responsible for any delay in submission of original documents.

A pre-tender meeting will be held on 28/02/2024 at **11.30 Hrs** at the office of Mumbai, Railway Vikas Corporation Ltd. 2nd Floor, Churchgate Station Building, Churchgate, Mumbai - 400020 as well as on video conferencing platforms like Cisco Webex/ Zoom (the link/ id to join will be intimated through corrigendum) to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITT Clause 7.4 of 'Instructions to Tenderers' of the tender document. Tenderers are advised to download the tender document prior to the pre-tender meeting in order for tenderers to have a good understanding of the scope of the requirements under this contract for discussion and clarification at the pre-tender meeting.
11. Other details can be seen in the tender document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the tenderers of any tender updates, the Employer shall not be liable for any information not received by the tenderer.
