The Government of Indonesia has received joint co-financing from the World Bank, Asian Infrastructure Investment Bank, and Asian Development Bank toward the cost of the **Indonesia Health Systems Strengthening Project** and intends to apply part of the proceeds toward payments under the contracts for **Procurement of Infant Warmers & Laboratory Major Analyzer**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing and Asian Development Bank's Loan Disbursement Handbook, except for those payments, which the contract provides to be made through letter of credit.
2. The Ministry of Health (MoH) now invites sealed Bids from eligible Bidders for **Procurement of Infant Warmers & Laboratory Major Analyzer (5,775 units)** that will be delivered, installed at several location including training, operational support and maintenance services. The expected delivery schedule shall be within two (2) years after the contract signing date.
3. Bidders may Bid for one or several contracts, as further defined in the Bidding document.
4. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" of September 2023 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

5. Interested eligible Bidders may obtain further information from Procurement Committee 4 IHSS, MOH through email at pc4_sophi@kemkes.go.id and inspect the bidding document during office hours at 09.00 to 16.00 local time at the address given below.
6. The bidding document in English can be sent to the interested eligible Bidders upon the submission of a written application to pc4_sophi@kemkes.go.id. The outer Bid envelopes marked "ORIGINAL BID", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on **February 20, 2025**, at **10:30 AM** Western Indonesia time. All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public opening.
9. All Bids must be accompanied by a Bid Securing Declaration.
10. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
