The Government of India has received financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Mumbai Urban Transport Project – III (MUTP-III), and intends to apply part of the proceeds toward payments under the contract for “Construction of Station Buildings, Service Buildings, Platforms, COP, FOBs and Subway including dismantling of existing structures at Chikhale, Mohape, Chowk and Karjat Stations in connection with Panvel-Karjat double line suburban corridor Project under MUTP-III”.
2. The Mumbai Railway Vikas Corporation Ltd. now invites online Tenders from eligible Tenderers for Construction of Station Buildings, Service Buildings, Platforms, COP, FOBs and Subway including dismantling of existing structures at Chikhale, Mohape, Chowk and Karjat Stations in connection with Panvel-Karjat double line suburban corridor Project under MUTP-III in 24 Months as detailed in the Table below. The tenderers may submit tenders for any or all of the Works indicated therein. Tenderers are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 5.9 of the “Procurement Policy of January 2016” and paragraph 4.4 of “interim Operational Directive on Procurement Instructions for Receipts, June 2016” setting forth the Asian Infrastructure Investment Bank’s policy on conflict of interest.
3. Tendering will be conducted through National Open Competitive Tender (NoCT) using Request for Tenders (RFT) as specified in the Bank’s Procurement Instructions for Recipients” (PIR), and is open to all eligible Tenderers as defined in the PIR.

4. Interested eligible Tenderers may obtain further information from Mr. K Jha, Chief Project Manager-I, e-Mail: cpm1@mrv.gov.in and inspect the Tender document during office hours 10.00 Hours to 18.00 Hours (IST) at the address given below.
5. The Tender document in English is available online on <https://eprocure.gov.in> from **20/03/2022 to 10/05/2023 (IST)**. A Tenderer who desires to participate in the Tender to pay a nonrefundable fee as indicated in the table below. The method of payment will be Demand Draft/ Cashier's Cheque/ Certified Cheque payable at Mumbai in favour of "Mumbai Railway Vikas Corporation Ltd." or direct deposit to MRVC Bank account number as mentioned in the Table below. Payment documents are to be submitted as per the procedure described in paragraph 9 below. Tenderers will be required to register in the website. The Tenderers would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tender document is also available on official website of MRVC <https://mrv.indianrailways.gov.in>". However, tenderer has to submit the tender only on procurement website <https://eprocure.gov.in>.
6. For submission of the tenders, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (www.cca.gov.in). Aspiring tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://eprocure.gov.in>.
7. Tenders comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted online on <https://eprocure.gov.in> on or before **13.00 Hrs of 10th May 2023 (IST)**. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic Tendering system would not allow any late submission of tenders. The "TECHNICAL PART" of the Tenders will be publicly opened online on the same day in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at **15.30** hours (IST), and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the second public Tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of Mumbai Railway Vikas Corporation Limited, Payable at Mumbai. Tender security will have to be in any one of the forms as specified in the tender document and shall have to be valid for 45 days beyond the validity of the tender. (The original tender security documents in approved form shall be submitted as per the procedure described in paragraph 9 below).
9. The tenderers are required to submit (a) original payment documents towards the cost of tender document and registration on e-procurement website (if applicable); (b) original tender security in approved form; and (c) original affidavit regarding correctness of information furnished with tender document, with Chief Project Manager-I, Mumbai, Railway Vikas Corporation Ltd. 2nd Floor, Churchgate Station Building, Churchgate, Mumbai-400020 before the Tender Opening deadline given above, either by registered post/ speed post/ courier

or by hand, failing which such tenders will be declared non-responsive, and will not be opened. The employer, MRVC is not responsible for any delay in submission of original documents.

10. A pre-tender meeting will be held on **5th April 2023** at **11.30 Hrs (IST)** at the office of Mumbai, Railway Vikas Corporation Ltd. 2nd Floor, Churchgate Station Building, Churchgate, Mumbai - 400020 as well as on video conferencing platforms like Cisco WebEx/ Zoom (the link/ id to join will be intimated through corrigendum) to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITT Clause 7.4 of 'Instructions to Tenderers' of the tender document. Tenderers are advised to download the tender document prior to the pre-tender meeting in order for tenderers to have a good understanding of the scope of the requirements under this contract for discussion and clarification at the pre-tender meeting.
11. Other details can be seen in the tender document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the tenderers of any tender updates, the Employer shall not be liable for any information not received by the tenderer. It is the tenderers' responsibility to verify the website for the latest information related to this tender.
